Let's Check In

Dana York, HVUUC Board of Trustees President

As we look forward to the selection of a new Minister, our 2021-22 Budget, Annual Meeting, and new Board of Trustees, I wanted to take a moment to tell you about some of the big decisions the Board has made this year.

Unexpected Expenses:

Hopefully you have sent in your pledge cards and remember that no amount is too small to commit to HVUUC to help with our ongoing ministry to our members and our region. We did have some big expenses this year. I wanted to share some information with you, so you would have some context for next year's budget and your pledge considerations.

Greg Kramer, our Facilities Trustee, as detailed in previous newsletters, has repaired our septic sump pump system that was not operational and painted and sheet rocked the main church (which looks great!). These capital repairs have cost us \$17,568 to date and we are still working on other building repairs.

We found out that we were not following a 2013 HVUUC commitment for our employee's retirement system, so we have made a retirement account fund adjustment of \$11,114 to date and may need to provide a few more dollars once the UUA analyzes our account. The church repairs and retirement account adjustments were above our approved budget for this year, and we are very lucky that these unexpected costs were able to be funded by the Board's Designated and Working Capital accounts due to your generous support in the past and the fund management of the current and previous Boards.

New Staff Leadership Model:

The Board decided that we would move to a minister lead staff leadership model with our new minister's arrival. What does this mean? It means that the use of the Personnel Committee structure, that changes each year, will not be used to supervise the staff of the church in the future, but that processes will be put in place for the minister to supervise our church staff with input from the Board of Trustees. Since the Personnel Committee is currently made up of the Past President, the Vice President and the current President (which changes each year) we have found that several issues have been lost in the transition of committee members annually, and we feel we may have not been fair to our employees or timely in informing them of their benefits, annual reviews, and training. A minister led leadership model and the establishment of a HVUUC Personnel Manual and policies, hiring, and employee appraisal documents will be standardized, allowing us to be more consistent with our current and future employees. Our goal is to have all the details worked out for this new leadership model in coordination with the new minister by December 2021.

When will We Meet in Person for Church?

The Board will continue to have a review monthly of our pandemic responses and, in coordination with the new minister and religious services committee, we will be looking at alternatives to meet together in person or virtually, or some combination in the future. This decision will be scientifically informed by guidelines from our state, local counties, the UUA-- and You! We are currently looking at guidance documents shared by the UUA for future church activities and we will keep you up to date on what we feel is appropriate for our church. However, I do want to quote Rev. Dr. Susan Frederick-Gray, our UUA President, when she recently talked about what we should do in consideration of reopening during this "in between time":

"Navigating this "in-between time" will be even more challenging than dealing with the early days of the pandemic. Those who are vaccinated may wish to start gathering in person sooner. Each person and family will have different levels of risk and risk tolerance. As leaders, we have to navigate complex decisions taking into account care for the whole of our communities—within and beyond our congregations. Our priority continues to be abiding care for the most vulnerable, within and beyond our congregations."

To help us continue our pandemic planning, look for another [church-wide survey](#) in May or June to help us gather information about what you think is appropriate for our church meetings in the future and to offer some ideas we have come up with for your consideration. Treasurer's Corner

As we begin the fourth quarter of our 2020/2021 fiscal year, our income is currently \$13,000 ahead of our spending, thanks to your continued support and the conscientious use of our funds. The summary table of our finances for the first three quarters is shown below.

Distinct from the budgeted finances, we have designated funds that are raised separately and used for unbudgeted expenses. Our Capital Repairs Fund started the fiscal year at \$18,000 and is now at less than \$100 due to septic system repair and sanctuary updates. The Board Discretionary Fund started the fiscal year at \$19,000 and is now at \$7,500 after an \$11000 payment was made to fulfill our contractual agreement with the UUA, as described in the President's report.

Direct donations to the church from your bank – it's easy!

Sending a donation the church directly from your bank is the same as setting up on-line BillPay. Using this function incurs no fees, compared to the 3% paid to PayPal.

There are two ways to set this up and both work fine.

- You can enter the church name and address as a payee, and the bank will send a check to the church.
- You can get the church's account number by emailing treasurer@hvuuc.org and enter this along with the name and address of the church. This will send your donation directly to our account. This makes it easier on our end since we don't have to submit the check to our bank.

That's it! No envelopes, no stamps, and no fees involved. Don't hesitate to email the treasurer at treasurer@hvuuc.org if you have any questions.

Gathering Guidelines

The Board of Trustees (BoT) voted to continue to hold virtual services and to continue the previously advertised facilities usage guidelines until **June 30, 2021**.

We are watching the Covid-19 cases in our area and will reevaluate at our June BoT meeting about extending this decision further.

The following Gathering Guidelines for small groups at our facilities (inside and outside of buildings) continue to apply.

Gathering Guidelines for Inside and Outside Church Facilities

We strongly recommend continuing to use online forums for small group/committee/team meetings. However, the HVUUC Board has voted to allow people on site for activities that must be held in person, e.g. work groups.

Only 1 group may meet at a time inside the church building. To schedule your meeting or workgroup and make sure other groups aren't already scheduled, please contact Karyn at office@hvuuc.org to reserve your group on the church calendar. You can check the calendar to make sure there aren't conflicts at: <https://localendar.com/public/hvuuchurch>

To locate the church calendar from the church website (hvuuc.org), go to the "News & Events" menu and select the 4th item, "Church Calendar of Events and Meetings," from the drop-down menu.

Additional Guidance

- No children's activities allowed at this time.
- Please do not bring children to any activity happening at the church.
- Groups of 10 people and less
- No more than 1 meeting of 10 people or less inside the church building.
- No more than 10 people in any 1 area of the outside property for workdays. For example, the entrance garden.
- Whenever practical, work projects should be divided into small groups or individuals.
- The Fred Ball room (fellowship hall), sanctuary, and deck are the only meeting areas that are open for use. The REZ is still off limits for meetings.
- People doing work projects may enter other locations, but must maintain at least 6 feet of distance while inside.
- Must wear a face mask (please bring your own)
- When working alone outside a face mask is not required. Face masks are required when working in groups of 2 or more.
- Anyone in the building must wear a mask.
- Must wash hands with soap and water for 20 seconds upon entering buildings, or use hand sanitizer and let air dry. Hand sanitizer is in several locations (foyer, kitchen, REZ), to be used as needed.
- Continue keeping a distance of 6 feet between people of different households.
- This is especially for inside activities but should also be adhered to when outside as much as possible.
- Whenever possible do not share work tools. If sharing occurs, wipe down handles with disinfecting wipes before returning the tool.
- Meals should be sack or box lunches, no family style meals, ie pizza. No water coolers or other communal drinking, ie punch. Maintain 6 feet of distance during meals.
- If you are ill, have a fever/cough, are someone who is at increased risk, or traveled to endemic areas infected with COVID-19, please stay home and enjoy online content and fellowship.
- Must clean commonly touched hard surfaces like door handles, light switches, counter tops, metal surfaces (chair backs), etc., when finished.
- Please use the cleaning wipes and/or bleach solution and paper towels in the foyer, kitchen, and REZ for cleaning/disinfecting after each visit.

Online Sunday services (on YouTube) will continue during this time. Virtual Religious Education (RE) activities for preschool through 12th grade will continue. Please register your children at [RE Reg form](#)
